The DataMover script (.dms) files identify the input data file (.dat) as well as the output log message file. The directory where DataMover looks for the input data file and the log file is specified in your Configuration Manager.

Special Note - Canada

Wage Loss Plans for Multiple Job Employees

In some situations, when an additional employment instance is created, the automatic tax functionality attached to this action only creates an additional row in the Wage Loss Plan section of the employee's tax data record. It does not create a new effective dated-tax record that reflects the date of the new employment instance.

In preparation for Canadian year-end, employers are advised to review the effective dates of the wage loss plans for their multiple job employees to ensure that the payroll information for each job is reported under the correct wage loss plan.

A fix for this issue will be delivered with Patch 18808902 (ADDING EMPL INSTANCE CREATES NEW ROW IN EMPL_WAGELS_CAN WITHOUT CORRESPONDING ROW) by the Human Resources product in a future HRMS bundle.

Special Notes - U.S. 2014 Year End Reporting

Ordering W-2 Forms for Tax Year 2014

In preparing to order W-2 forms for tax year 2014, employers should consider the following issues:

Employers who will be reporting W-2 data to any state where their state Employer Identification Number (EIN) is greater than 12 characters in length should <u>not</u> order Form ID LSR02A (the "four-corner" format which prints four W-2s per page at the four corners of the page). W-2 Form ID LSR02A does not provide sufficient space in box 15 to print State EINs that exceed 12 characters.

States that are currently known to issue Employer Identification Numbers that exceed 12 characters include Kansas, Utah, and Wisconsin. Employers who are considering ordering W-2 Form ID LSR02A should first review all of their state EINs to confirm that none of them exceed 12 characters in length.

Employers who report W-2 data for **New Jersey** should be aware that, because of the unusually large number of data items that New Jersey requires to be individually printed on Form W-2, there is a very high incidence of data overflow that results in the printing of a second New Jersey W-2 form for each employee with New Jersey reportable data.

To avoid running short of W-2 forms, in determining the quantity of forms to order, it is suggested that employers anticipate that two forms will be needed for each instance of an employee with W-2 data to be reported to New Jersey.

Employers who report W-2 data for **Pennsylvania** should be aware that, because of the implementation of Pennsylvania Act 32 in tax year 2012, employees who reside and/or work in multiple Pennsylvania local tax jurisdictions will have a higher number of W-2 forms produced than before Pennsylvania Act 32. A separate employee Tax Balance record is created each time that Pennsylvania Local Earned Income Tax is withheld from an employee for a different Political Subdivision (PSD) Code, and each tax balance record represents a separate iteration of local wage and tax data which must be reported on Form W-2.

Data for two local tax jurisdictions can be printed on each Form W-2 using these Form IDs:

LSP03 LSR03P LPS4V

Data for only one local tax jurisdiction can be printed on each Form W-2 using these Form IDs:

LSR01 LSR02A XMLP 4 vertical XMLP pressure seal

To avoid running short of W-2 forms, in determining the quantity of forms to order, employers should consider the mobility of their Pennsylvania employee population.

It is strongly recommended that you set Locals per Form = 1 if you will be reporting Pennsylvania Local Earned Income Tax amounts on Form W-2. Some Pennsylvania tax collecting agencies have indicated that employers should not report data for more than one Pennsylvania locality on a single Form W-2. Do not set Locals per Form = 2 unless the Tax Collection District the forms will be submitted to has confirmed that printing two sets of local tax data on a single Form W-2 is acceptable.

Special Note - Preparing for U.S. Year End Reporting 2014

After you have followed the instructions in the "PeopleSoft Application Update Installation Instructions" to apply the object changes delivered in this tax update, you are ready to update your year end tables for 2014 U.S. year-end wage and tax reporting. Refer to the separate document **Year End Processing 2014: U.S.**, **Puerto Rico**, **and U.S. Territories** delivered with this tax update for detailed instructions on year-end processing with PeopleSoft Payroll for North America.

PRELIMINARY STEP for NEW PeopleSoft Payroll Users only (processing Year End in PeopleSoft Payroll for the first time in 2014)

If 2014 will be your *first* year producing Form W-2 for U.S. employees using PeopleSoft Payroll for North America, you must contact Oracle Software Support to request the special script described in Solution Document ID 635458.1. You must run this special script to prepare your Tax Form Definition Table for 2014 year-end processing. Running this script will ensure that your Tax Form Definition Table is current up through 2013 year-end changes.

Follow these steps to set up tax reporting tables for tax year 2014:

1. Update and Review Tax Form Definitions.

Follow these instructions to add Tax Form Definitions table entries for 2014.

IMPORTANT: You must complete this manual step <u>before</u> proceeding to use Change Assistant to apply the DataMover scripts delivered with Tax Update 14-E.

- a. Enter the Tax Form Identification **W-2** and the Effective Date of **01/01/2013** on the Tax Form Definitions search page and select Search. Add a new row in the table that duplicates all of the 2013 entries by selecting the Add (+) button in the "Effective Date" Group Box. Change the Effective Date for this newly inserted row to **01/01/2014**. **Save this new entry.** Then follow this same procedure for Tax Form Identifications W-2c, W-2AS, W-2cAS, W-2GU, W-2cGU, W-2PR, W-2cPR, W-2VI, and W-2cVI. **Save these new entries.**
- b. Update 2014 Tax Form Definitions table entries with any new earnings or deductions required for 2014 year-end processing. **Save your changes.**

To update the Tax Form Definition Table with a new earnings or deduction, the Effective Date of the Earnings Table or Deductions Table entry must match the Effective Date of the Tax Form Definition Table entry you are updating. For example, if you are updating a Tax Form Definition Table entry dated 01/01/2014, then the Effective Date on the Earnings Table or Deduction Table entry of the earnings or deduction being added to the Tax Form Definition Table entry must also be 01/01/2014. If necessary, in Correction mode, temporarily change the Effective Date of the Earnings Table or Deduction Table entry to match the Effective Date of the Tax Form Definition Table entry, update the Tax Form Definition Table entry with the earnings or deduction and save the change, and then, again in Correction mode, return the Effective Date of the Earnings Table or Deduction Table entry to its original date.

- c. To update your Tax Form Definitions table for 2014 Form 940 reporting, enter the Tax Form Identification **940** and the Effective Date of **01/01/2013** on the Tax Form Definitions search page and select Search. Add a new row in the table by selecting the Add (+) button in the "Effective Date" Group Box and change the Effective Date for this newly inserted row to **01/01/2014**. Enter information for any earnings or deductions that should be defined as FUTA-exempt for 2014 FUTA Form 940 reporting. **Save this new entry.**
- d. Run TAX710 to print a listing of 2014 Tax Form Definitions table entries and review for accuracy.

Tax Form Definitions for Puerto Rico Form W-2PR for 2014 will be delivered in a future tax update.

- 2. Update and review Tax Form Print Parameters.
 - a. Run the DataMover script **upd903199_04.dms** provided in Tax Update 14-E. This script adds 2014 entries to the Tax Form Print Parameters table for Forms W-2, W-2AS, W-2GU, and W-2VI.
 - b. Update the 2014 Tax Form Print Parameters table entries to print any items of data you have added to the 2014 Tax Form Definitions table entries for any year end forms. **Save your changes.** (You must **always** update Tax Form Print Parameters table entries for any non-PeopleSoft delivered items you have added to the Tax Form Definitions table.)
 - c. Run TAX712 to verify that 2014 entries have been added to the Tax Form Print Parameters table.

Tax Form Print Parameters for Puerto Rico Form W-2PR for 2014 will be delivered in a future tax update.

- 3. Review and update data on the Annual Tax Reporting Parameters page(s) for year-end reporting.
 - a. Select the tax year in the Balances for Year field.
 - b. Enter the Company ID of the company that will be transmitting W-2 data electronically in the Transmitter ID field.
 - c. Select the appropriate entry in the Organization Type field.
- 4. Review the Tax Report Type field on the Company Table-Tax Details page and update for 2014 year-end reporting if necessary.
- 5. Review and update data on the W-2 Company Data page for year-end reporting.
 - a. Update the W-2 Company Data page with entries for calendar year 2014.
 - b. Select the appropriate values for the Kind of Employer and Type of Employment fields.
 - c. Review/update the Employer Contact information in the RE Record Values group box.
- 6. Run the DataMover script **upd903199_05.dms** to update the Tax Form XMLP Options Table with 2014 U.S. year-end form PDF templates for XMLP processing.
- 7. Update the Year End Form Options Table by manually adding a new row for Tax Year 2014 for each W-2 Reporting Company.

Special Note - U.S. Federal

U.S. Treasury Interface - Payment Application Modernization (PAM)

Tax Update14-E delivers the second installment in a series of product modifications to support the new Treasury Interface PAM/SPR and SPS formats that include reporting Componentized Treasury Account Symbols (TAS) and Business Event Type Codes (BETC); government agencies are required to begin using these new formats no later than October 1, 2014.

Taxable Gross Definition Table

Tax Update 14-E delivers an update to each of the previously existing Taxable Gross Definition table entries that includes an Adjustment to Base Gross for Taxable Gross Component ID "SSP" with Other Rate ID = **Spouse - SS Rate**.

Other Rate ID = **Spouse - SS Rate** is used to identify the portion of an employee deduction or employer-paid contribution amount that represents the cost of benefits provided to an employee's same-sex spouse which is *excluded* from U.S. federal taxable wages, but which must be *included* in the definition of taxable wages for state and local tax jurisdictions that do not recognize same-sex marriage.


As illustrated below and on the following page, for each Adjustment to Base Gross entry in the Taxable Gross Definition table that includes Other Rate ID = Spouse - SS Rate, Tax Update 14-E delivers an additional corresponding Adjustment to Base Gross entry with Other Rate ID = **Children - SS Rate**.

Other Rate ID = **Children - SS Rate** is used to identify the portion of an employee deduction or employer-paid contribution amount that represents the cost of benefits provided to the children of an employee's same-sex spouse which is *excluded* from U.S. federal taxable wages, but which must be *included* in the definition of taxable wages for state and local tax jurisdictions that do not recognize same-sex marriage.



Taxable Gross Definition Table entry with Effective Date = 09/16/2013 BEFORE Tax Update 14-E:




Taxable Gross Definition Table entry with Effective Date = 09/16/2013 AFTER Tax Update 14-E:

Patch Description

17973058 Patch 17973058 modifies PSPDARRY.CBL and PSPDARRY.DMS to correctly apply arrears payback amounts in the following sequence of events:

- 1. Initially employee is enrolled in a Benefit Plan with the coverage code "1" tied to deduction code "ABC".
- 2. Because the employee has insufficient earnings, the deduction amount is placed in arrears.
- 3. Subsequently the employee changes from coverage code "1" to coverage code "2" which is tied to deduction code "DEF".

Prior to the modifications, when the payroll was processed, instead of applying the deducted amount towards the arrears generated for deduction code "ABC", the amount was incorrectly applied towards the current deduction code "DEF".

Patch 18316849 modifies PSPPYNET.CBL to prevent the generation of an erroneous record of Pennsylvania Local Earned Income Tax data for a non-existent Pennsylvania residence locality when an employee with before-tax deductions is a resident of a local tax jurisdiction in a state other than Pennsylvania and is paid for work in three or more locations which include (1) Philadelphia. (2) State = PA with Locality = BLANK, and (3) a location in a state other than Pennsylvania.

Prior to the modifications, in this scenario, an erroneous tax row was generated for a Pennsylvania resident locality even though the employee was not a resident of PA.

Patch 18323084 modifies PSPPYNET.CBL to correctly calculate Pennsylvania taxable wages and to prevent the generation of erroneous records of Pennsylvania Local Earned Income Tax data for an employee in the following situation:

- 1. The employee is a resident of either New Jersey or New York; and
- 2. The employee's pay calculation includes one or more before-tax deductions; and
- 3. The employee's earnings includes pay for work performed in three work localities: (a) the employee's resident state, (b) State = PA/Locality = 510101 (Philadelphia), and (c) State = PA/Locality = BLANK; and
- 4. The amount paid for State = PA/Locality = 510101 (Philadelphia) includes both (a) nontaxable expense reimbursement and (b) imputed income for excess group-term life insurance processed as an earnings.

Prior to the modifications, in the above-described scenario, two erroneous rows of tax data were created for Pennsylvania state withholding tax (one row displaying only taxable gross and tax dollar amounts, and the other displaying only a tax dollar amount and PSD Code 880000, but no taxable wages).

Patch Description 18707047 Patch 18707047 modifies PSPTCALC.CBL, PSPUSTAX.CBL, and copy member PSCTXLNK.CBL to correctly process Pennsylvania Local Service Tax (LST) calculations when an employee's pay period taxable wages for the LST tax jurisdiction are below the Low Gross Threshold for the jurisdiction or the Pennsylvania statewide Low Income Exemption (\$12,000), but the combined total of PA LST taxable wages gross on the currently calculated check plus the employee's prior YTD taxable wages for the LST jurisdiction meet or exceed the Low Gross Threshold or the Low Income Exemption amount. Prior to the modifications, Pennsylvania Local Services Tax was not calculated or deducted in the above-described situation. 18751561 Patch 18751561 modifies PSPMFLSA.CBL to correctly calculate taxable gross and tax amounts for the New York MTA Payroll Tax for an employee whose current paycheck includes prior period FLSA adjustments. Prior to the modifications, New York MTA Payroll Tax taxable gross and tax amounts were not calculated for employees whose current paychecks included FLSA adjustments for prior pay periods. 19158313 Patch 19158313 modifies PSPOLCDL.DMS by changing the naming of the PSPOLCDL D TXGRE store statement to PSPOLCDL D TXGREL. Prior to the modifications, this store statement was out of sync with the matching SQL statement in the COBOL program, which may have resulted in a PeopleCode error indicating that the store statement for D_TXGREL could not be found when producing an online check. 19221668 Patch 19221668 modifies copy member PSCCTXRT.CBL to allow for the new signed version of the field PIT-KP. The field PIT-KP was modified to make it a signed number, and the record PS CAN TAX PROVTHR was modified to allow the record to be regenerated. Note that not all databases will require the record to be regenerated if the database field is already defined as signed. These changes allow for the introduction of a negative KP value which was introduced by Ontario effective September 1, 2014. Prior to the modifications, negative values were not allowed for field PIT-KP. (Patch 19221668 posted to My Oracle Support as Patch 19329146 on 17 August 2014)


